#### North Dakota Legislation


North Dakota State Director Tony Mutzenberger (Lieutenant Colonel – Retired) and SSS Legislative Liaison Jacob Daniels are busy working on driver's license legislation in North Dakota. House Bill 1415 will automatically register men between the ages of 18 and 25 with Selective Service when they apply for (or renew) a North Dakota driver's license, driver's permit, or identification card. The legislation was approved by the North Dakota House of Representatives and will be voted on, in March, by the North Dakota Senate. In February, Daniels joined Mutzenberger at the North Dakota state legislature to thank the sponsors of the legislation, on behalf of the Director, and to discuss the

importance of passing HB 1415 with a bipartisan coalition of Senate leaders. If all goes as planned, North Dakota will be the 41st state to enact and implement driver's license legislation.
